At the close of each season the eLandings team evaluates the tLandings application in an effort to simplify use while maintaining a stable reporting system. Processor and agency staff contact us requesting additional data collection and the team reviews issues that require user support assistance.

Modifications to tLandings to simplify reporting began in 2016 with the change in tender user accounts and logins. For 2017, we are restructuring tender vessel operations as well as redesigning the tLandings application to harvest both the permit and the vessel information from the CFEC permit card. This will eliminate the need for vessel lists and should speed the reporting process.

To better understand these significant changes to the tLandings application, we highly recommend you attend the tLandings workshop as the application will be changing significantly in 2017. These changes will be reviewed at the workshop and we hope that you and your staff will make every effort to attend.

Topics that will be reviewed include the following:

- · Tender operations and user account management
- · Review of new application features and enhancements
- Revisions to the tLandings reporting process
- Efficient data correction practices
- Regulation changes at ADF&G and NMFS as it relates to tLandings for groundfish
- eLandings integrated COAR reporting
- Web resources
- Review procedures to append setnet site fish ticket when multiple landings occur

eFISH

eFISH is a web application that provides NMFS permit holders with access to their account information. There are a variety of different user categories and actions that can be taken dependent upon the type(s) of permits associated with each account.

eFISH is also home to the *Registered Buyer* report where IFQ fisher's submit their halibut and sablefish landings. This is used by catcher sellers that don't deliver to shoreside processing plants. Documentation on eFISH can be found <u>HERE</u>.

- IFQ permit holders can view their account balances, run landing ledger reports, print permits, or update their account information.
- Registered Buyer permit holders can renew their permits, submit exvessel volume reports, and pay Observer fees.

• CDQ groups can view IFQ and IPQ account balances, check use caps, run landing ledger reports, display vessel caps, print annual permits, transfer psc/psq, exchange flatfish, and pay cost recovery and observer fees.

Display IFQ/IPQ Balance	Displays IFQ or IPQ account balances by fishery for the current fishing year. Select a permit if you wish to display balances for one IFQ/IPQ permit only: Optional Permit#
Display Landing Ledger	Displays a landing ledger report for a selected IFQ or IPQ permit for the selected crab fishing year.
Display Quota Share Holdings	Displays a report of quota share (QS) holdings
Check Use Caps	Check QS/PQS and IFQ/IPQ Use Caps.
Print Permits	Print Annual Permits.

Vessel Balances

Displays vessel balance by fishery for the current fishing year.

• CDQ, A80, AFA, and Rockfish program cooperatives can display account balances, submit transfers, and pay cost recovery fees.
